PROVISIONS

1. Rental fees for the Desert Sage Event Center/Malheur County Fair: \$1000.00 Deposit to hold your date, remainder shall be due within 14 days prior to the event.
2. The Lessee agrees to cause no damage to the leased premises and at the termination of the lease to return to the Lessor the leased premises and property in the same condition they were at the time of Lessee's taking possession.

3. It is expressly understood and agreed that the Lessee shall comply with all rules and regulations adopted by the State, County, City or any other body politic which pertains to the said use of said premises.
4. **NO** glass bottles allowed.
5. **Marijuana, in any form, is NOT allowed on the facility. If security guards discover marijuana being used the event may be shut down.**
6. Uniformed Oregon Certified Security Guards are required when alcohol is on premises.
(Alcohol allowed from 4:00 p.m. – 11:00 p.m.)
7. **No Alcohol served after 11:00 p.m. – Music to end at 11:30 p.m.**
8. Music must be kept low after 10:00 pm, due to fairgrounds being located within Ontario City Limits.
9. **Parking only allowed in the designated parking area, all other parking is to be in the parking area outside the facility fence. No parking by the horse stalls (backside of the grandstands).**
10. Lessee will make no alterations, additions, improvements or change to or upon said premises without the written consent of Lessor. Upon receiving written consent installation and removal of any alterations, additions, improvements or changes will be entirely at the expense of the Lessee.
11. This Lease shall not be assigned or sublet without the written consent of the Lessor.
12. It is further understood and agreed that Lessee agrees to save Lessor and its employees and agents harmless from all claims of damages, suits at law, and criminal and civil complaints which may be instituted as a result of Lessee's occupancy of the premises covered by this lease.
13. **\$1000.00 deposit fee may be refunded if facility is left clean with no damages or other expenses incurred due to venue. (see attached cleaning requirements) AND if there aren't any additional security issues.**
14. **Malheur County Fair/Desert Sage Event Center holds the right to bill the lessee for additional costs over and above the deposit fee for cleaning, damage or security expenses.**
15. **It is the responsibility of the Lessee to provide water truck and equipment to return the arena to its original condition prior to use.**
16. **All guests must stay within the designated area of the event.**
17. Malheur County Fair Event Rules will be followed.
